SUMMARY ANNUAL REPORT for BAY AREA PAINTERS AND TAPERS ANNUITY FUND

This is a summary of the annual report for Bay Area Painters and Tapers Annuity Fund, EIN 94-6276501, for the year beginning January 1, 2018 and ending December 31, 2018. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided in whole from Trust assets. Plan expenses were \$14,021,115. These expenses included \$422,976 in total operating expenses, \$100,000 in investment expenses and \$18,760,033 in benefits paid to participants and beneficiaries. A total of 11,489 persons were participants in or beneficiaries of the Plan at the end of the Plan year.

The value of Plan assets, after subtracting liabilities of the Plan, was \$311,697,773 as of December 31, 2018 compared to \$297,676,658 as of January 1, 2018. During the Plan year the Plan experienced an increase in its net assets of \$14,021,115. This increase included unrealized appreciation in the value of Plan assets, that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$33,304,124, including employer contributions of 46,304,881, losses from investments of \$13,375,339, and other income of \$374,582.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
